VILLAGE MANAGER REPORT

Village Manager Uhl reported that Toyota should be breaking ground in the next day or so. The Outer Drive project is coming along nicely. Parks & Rec requested the soccer fields be lined on the 26th of March. Due to weather, the lining will take place at a later date. The Hampton Inn is coming along. Great Lakes Eatery will open after final inspections. The Dundee Community Schools will be interviewing the three applicants for the school liaison officer. Someone is looking at the property next to Auto Zone. Three units have been rented at Scheich's new apartment complex. The foundation work and brick wall repairs on the Main Street corner property should start shortly.

COUNCIL COMMENTS

Tr. Polito thanked the DPW for their work in keeping the river front attractive. Tr. Salib made comments on the shovel ready status of the community which is an asset to community growth. Tr. Bordine commented on the need for lights on the corner of Tecumseh and South and Mechanic Streets. President Gutierrez suggested that directional signs for municipal parking lots be installed. She requested that the brick on the back of the monument in Memorial Park be investigated for possible deteroiation.

With no further business before the Council the Regular Council Meeting was adjourned at 8:10 pm.
